Supplemental Flu Ordering Now Available

VFC Supplemental Flu Ordering is now available. Providers who were not able to submit their initial flu order confirmation may submit orders for flu doses. Providers may log on to their "MyVFCVaccines" account and click on the "Supplemental Flu Order" button to access supplemental flu ordering.

For providers that confirmed their initial flu allocations, the availability of supplemental flu ordering to providers is contingent upon the following factors:

- Available flu vaccine supply
- Provider's receipt of confirmed products in full. The VFC Program will be processing additional doses of the following flu products confirmed during the initial ordering period as listed below. Vaccine shipments can be expected to begin arriving towards the end of this week depending on your practice's shipping days and hours.

Product	VFC Age Group	Processed
Fluzone® Quadrivalent P-Free Pediatric Formulation 0.25mL single dose syringes, Sanofi Pasteur	6-35 months	For orders over 100 doses, the remaining 15% balance of confirmed doses will be shipped. This completes shipment of all initial allocations.
Fluzone® Quadrivalent Multi-Dose Vial 10 dose vials (5mL), Sanofi Pasteur	3-18 years	For orders over 100 doses, the remaining 35% balance of confirmed doses will be shipped. This completes shipment of all initial allocations.
Fluarix® Quadrivalent Preservative Free Formulation 10 pack - 1 dose syringes (0.5mL), GSK	3-18 years	For orders over 100 doses, the remaining 10% balance of confirmed doses will be shipped. This completes shipment of all initial allocations.
FluMist™ Quadrivalent Nasal Sprayer 10 pack-1 dose Intranasal Spray, MedImmune	Healthy 2-18 years	100% of all initial allocations have already been shipped.

Note: All provider orders 100 doses or less have been shipped in full for all formulations.

Please keep in mind the following key points when submitting supplemental flu orders:

- Confirm that shipping days and hours listed on your "MyVFCVaccines" account are updated to ensure a successful delivery of your flu vaccine shipment.
- There is a limitation on the number of doses that can be ordered through the online supplemental order system. If your practice needs more supplemental doses than the system will allow you to order, please contact the VFC program.
- Once supplemental orders are placed, additional supplemental orders may not be submitted until your pending order has been processed and shipped.
- Providers may submit additional supplemental flu orders as needed throughout the season and as supply permits.
- Supplemental orders will be shipped in full to practices. Make sure you have adequate space in your refrigerator to store vaccines immediately upon arrival.
