TPR Refrigerated Shipment, McKesson Delays, and Information for Critical Weekly Meetings

Third-party Redistributor Transitions from Dry Ice to Refrigerated **Shipments**

Third-party Redistributor (TPR, AmerisourceBergen) started transitioning from dry ice to refrigerated shipments last week. The tentative timeline for the final transition of all Pfizer pediatric (5-11 years, orange cap) shipments to refrigerated is January 18. The tentative timeline for the final transition of all Pfizer Tris-sucrose (12+ years, gray cap) shipments to refrigerated is January 31. Please review the job aids below for additional assistance.
