

# **COVID-19 Vaccine Reimbursement**

### **Quick Guide**

To help physicians better understand the guidance on COVID-19 vaccine administration reimbursement, CMA has compiled the following information.

#### **CPT** Guidance

The new vaccine administration CPT codes are specific to the manufacturer and the first vs. second dose.

| Manufacturer                | National Drug Code | Vaccine Serum CPT | 1st Admin CPT | 2 <sup>nd</sup> Admin CPT |

# Reimbursement and Billing Information

**PATIENT COST SHARING** – Since the federal government is supplying the vaccine itself at no cost, vaccination providers are only able to be reimbursed for administering the vaccine. There should be **no patient cost sharing for all payor types** for vaccine administration regardless of whether the service is provided by an in-network or out-of-network provider.

## **Medicare Fee-For Service and Medicare Advantage**

For 2020 and 2021, the Centers for Medicare and Medicaid Services (CMS) is carving out the COVID-19 vaccine administration benefit from the Medicare Advantage plans and will reimburse under the Medicare fee-for-service system. To avoid delays or denials in payment, **physicians will need to ensure claims for Medicare Advantage enrollees are submitted directly to Noridian, the Medicare Administrative Contractor**. Claims must be submitted under the patient's Medicare Beneficiary Identification number indicated on their original Medicare ID card.

**CLAIM SUBMISSION** – Claims should be submitted to Noridian with the patient's original Medicare ID number, rather than the Medicare Advantage ID number.

BILLING - Claims should include the vaccine administration CPT codes only.

#### **REIMBURSEMENT RATES -**

Dates of service through March 14, 2021

+ Single dose vaccines: \$28.39

+ Vaccines requiring 2 or more doses:

Initial dose: \$16.94Second dose: \$28.39

Dates of service on or after March 15, 2021

+ \$40 for each dose required

### Medi-Cal Fee-For-Service and Medi-Cal Managed Care

Consistent with the approach taken by Medicare for Medicare Advantage plans, The Department of Health Care Services is also carving out the COVID-19 vaccine administration reimbursement from the Medi-Cal managed care system and will reimburse under the fee-for-service (FFS) delivery system. To avoid delays and denials in payment, physicians will need to ensure claims for COVID-19 vaccine administration **are submitted to Medi-Cal FFS** rather than the Medi-Cal managed care plans. Physicians should follow the Provider Manual for Medi-Cal FFS billing and submit claims with the patient's Medi-Cal Benefit Identification Card (BIC) number rather than the Medi-Cal managed care ID number.

**CLAIM SUBMISSION -** Medi-Cal FFS and Medi-Cal managed care claims should be submitted directly to Medi-Cal FFS with the patient's Medi-Cal FFS BIC ID number, rather than the Medi-Cal managed care plan ID number.

BILLING - Claims should include the vaccine administration CPT codes only.

#### **REIMBURSEMENT RATES -**

Dates of service through March 14, 2021

- + Single dose vaccines: \$28.39
- + Vaccines requiring 2 or more doses:
  - Initial dose: \$16.94Second dose: \$28.39

Dates of service on or after March 15, 2021

+ \$40 for each dose required

#### **Commercial Plans Regulated by the Department of Managed Health Care**

**CLAIM SUBMISSION** - Bill plan/delegated group as you normally would, unless notified otherwise by plan/delegated group.

**BILLING** - Claims should include the vaccine administration CPT codes only.

**REIMBURSEMENT RATES** – In-network physicians will be reimbursed at their contracted rate. Per DMHC, out-of-network providers must be reimbursed at a "reasonable rate," which CMS guidance suggests is the Medicare rate for COVID-19 vaccine administration. (See DMHC <u>APL 20-039</u>.) Physicians seeking specific billing or reimbursement guidance should visit the plans websites:

- + Aetna
- + Anthem Blue Cross
- + <u>Blue Shield of California</u> Rather than billing the delegated group, Blue Shield announced it is assuming financial responsibility for COVID-19 vaccine administration costs. Effective for dates of service on and after December 11, 2020, practices should bill Blue Shield directly.
- + Cigna
- + Health Net
- + UnitedHealthcare

#### **Insurers Regulated by the California Department of Insurance**

**CLAIM SUBMISSION** - Bill insurer as you normally would.

**BILLING** – Claims should include the vaccine administration CPT codes only.

**REIMBURSEMENT RATES** – In-network physicians will be reimbursed at their contracted rate. Per CDI, out-of-network providers must be reimbursed at a "reasonable rate," which CMS guidance suggests is the Medicare reimbursement rate for COVID-19 vaccine administration. #### **ERISA plans**

The CARES Act requires self-funded plans to cover the administration of COVID-19 vaccines with no cost share (copayment, coinsurance or deductible) for in- or out-of-network providers during the national public health emergency.

#### **Uninsured Patients**

For individuals who are uninsured, providers will be able to be reimbursed for administering the COVID-19 vaccine through the Provider Relief Fund, administered by the U.S. Health Resources and Services Administration.
