2021-2022 VFC Influenza Vaccine Shipments for Delivery the Week of 9/27/21

Dear VFC Provider,

The California Vaccines for Children (VFC) Program will continue processing influenza vaccine orders for products that are currently available at McKesson. Percentages of initial orders are listed below. Orders will be processed on Friday, September 24, 2021 for shipments arriving the week of September 27, 2021.

IMPORTANT! If your clinic will be closed in the next few weeks or you do not have the capacity to store additional flu vaccines at this time, please notify the VFC Program by Thursday, September 23, 2021 at 1-877-243-8832 to prevent any shipping incidents.

FluLaval® Quadrivalent Preservative Free 0.5mL, Single-Dose Syringes, GSK	6 months-18 years	Orders of 100 doses or less have been shipped in full. Orders over 100 doses: The remaining 30 % of initial orders

Fluzone® Quadrivalent Preservative Free 0.5mL, Single-Dose Syringes, Sanofi	6 months-18 years	Orders of 100 doses or less have been shipped in full. Orders over 100 doses: No additional doses have been received by the manufacturer as of 9/21/2021. Percentage may change by the end of the week.
FluMist® Quadrivalent Preservative Free 0.2mL, Intranasal Sprayer, AstraZeneca	2-18 years	Orders of 100 doses or less will be shipped in full. Orders over 100 doses: The remaining 50 % of initial orders will be shipped, completing initial orders for this product.
Flucelvax® Quadrivalent Preservative Free 0.5mL, Single-Dose Syringes, Seqirus	2-18 years	100% of initial orders have been shipped in full.

Subsequent shipments for the remaining balance of shipped orders will be automatically processed as soon as additional vaccine doses become available.

For Providers that pre-booked Fluzone®: Due to delays in receiving additional product from this vaccine manufacturer, we have received provider requests to see if they can receive doses from a different product. In response to these requests, VFC may be able to change a portion of your pre-book to an alternate flu vaccine product. Please email myVFCvaccines@cdph.ca.gov by September 23, 2021 and include the following information:

- VFC PIN Number
- Number of doses you would like to shift from Fluzone® to an alternate flu product
 - You may shift up to 50% of your Fluzone[®] initial order to either FluLaval[®] or Fluarix[®]

 Refer to your initial flu order confirmation email that was sent on July 30, 2021 to determine your approved initial flu order.

Note: Your practice will still be responsible for ordering the remaining doses pre-booked of Fluzone.
