KidsVaxGrant Launching in April – Up to \$25K for Your Practice!

CDPH is partnering with Physicians for a Healthy California (PHC) to launch the KidsVaxGrant program, offered exclusively **to VFC providers**. The goal of this grant opportunity is to expand the pediatric vaccination network to ensure that <u>California's most vulnerable children</u> get vaccinated against COVID-19.

The KidsVaxGrant aims to support VFC Providers who may be newly enrolling in the COVID-19 vaccination program, as well as provide additional support to those providers already enrolled in COVID-19 with expansion of vaccination capacity:

- VFC providers who enroll in the COVID-19 Vaccination Program (myCAvax) from December 17, 2021 through April 30, 2022 can receive **\$10K***.
- Enrolled VFC providers can receive \$15K if they open their doors for at least 15 hours beyond their normal business times to provide additional vaccination options for working families!

KidsVaxGrant Details

Funding is limited and the deadline to submit your application is May 27, 2022. PHC will open the grant application portal in early April. VFC Providers currently not enrolled in the COVID-19 Vaccination Program must enroll by April 30, 2022 to qualify. ^{*} VFC Providers who received a CalVaxGrant are eligible for the \$15K-for-15 hours program only.

Why Enroll in the CA COVID-19 Vaccination Program Now?

- COVID-19 vaccine is an ACIP-recommended vaccine, just like all other
 pediatric and adolescent vaccines you are currently administering in order to
 protect your patients. Though the vaccine is not offered through VFC, you may
 order it and receive it via the COVID-19 Program. COVID vaccine doses may be
 administered to all your patients, regardless of insurance status.
- Enrollment in the Program has <u>never been easier for VFC providers</u>. Our COVID-19 Program Enrollment Team and Provider Call Center staff are closely working with the VFC Program to support you in this process.
- Higher Reimbursement for Administration Fees: COVID-19 providers are reimbursed \$40 per dose for administration fees – much higher than the reimbursement for VFC vaccines!
- **MHOAC Program:** Sites may request supplemental staff at no cost through your <u>local Medical Health Operational Area Coordination (MHOAC)</u> program.
