## Vaccines for Children (VFC) Program Transitioning to myCAvax – Next Week!

Dear VFC Provider,

We are just one week away from completing our Vaccines for Children (VFC) Program operations transition to myCAvax on **June 10, 2024**. Please keep in mind the following important items and key actions related to this transition!

1. Know the difference between EZIZ, MyVFCVaccines, and myCAvax:

**EZIZ** is a website that hosts resources and communications for California's vaccine programs such as the Vaccines for Adults (VFA) and Vaccines for Children (VFC) Programs. It also hosts the required training lessons for VFC, VFA, and LHD 317 program participation. The transition does not have any affect on EZIZ and it will still serve as the VFC Program's resource page.

**MyVFCVaccines** is the system all VFC Providers use today to submit their VFC vaccine orders, returns, waste, and complete account management activities like staff changes and annual recertification.

**myCAvax** is the new system all VFC Providers will use starting June 10, 2024 and moving forward for all VFC-related activities MyVFCVaccines is used for today.

2. MyVFCVaccines is now closed to all account edits such as orders, returns, and provider profile updates (i.e. data logger updates, staff changes, etc.). If any last minute changes need to be made to your vaccine coordinator and/or backup vaccine coordinator to ensure the correct people have access to your VFC account(s) in myCAvax on June 10, please fill out the updated temporary Key Practice Staff Change Request form and send to us at MyVFCVaccines@cdph.ca.gov, or by fax at 877-329-9832.

**NOTE:** The Storage and Handling Online Triage System (SHOTS) will remain available in your MyVFCVaccines account through June 9, 2024. Please continue to document and report all temperature excursions to SHOTS until we fully transition all VFC activities to myCAvax on June 10, 2024.

3. myCAvax training sessions are offered to all VFC Providers and are ongoing through June with slots still available, so <u>register now!</u> After training is complete, review the recording, slide deck, and FAQs from each training to cement your knowledge.
