Vaccines for Children (VFC) Program Transitioning to myCAvax – Provider Training Approaching!

Dear VFC Provider,

The Vaccines for Children (VFC) Program will be transitioning its vaccine ordering and provider management system, MyVFCVaccines, to a new system, myCAvax, on **Monday, June 10, 2024**. To prepare your practice for this transition, and get familiar with myCAvax, we will offer several live training sessions intended for key practice staff (i.e., primary and backup vaccine coordinators) who will be responsible for ordering and managing VFC vaccine in myCAvax.
