2025-2026 VFC Influenza Vaccine Shipments Coming Soon!

Dear VFC Provider,

The California Vaccines for Children (VFC) Program has begun receiving supply of this year's influenza vaccines. Therefore, we will begin processing influenza vaccine orders for providers who have pre-booked flu products that are currently available at McKesson. The VFC Program has received supply of Fluarix, FluLaval, and Flucelvax. Products from Sanofi and AstraZeneca are not yet available. Percentages of initial orders that will ship are listed below.

Initial orders for providers that pre-booked will be processed the week of August 11 for shipments arriving the following week. This is a change from last season and providers that pre-booked flu vaccine earlier this year do NOT need to submit a vaccine order form to receive their initial 2025-2026 flu vaccine shipments.

If you did not pre-book flu vaccines, doses will be allocated based on remaining supply. Primary and backup vaccine coordinators will receive an e-mail notifying them when doses are allocated to your location(s), along with instructions on how to request those allocated doses.

IMPORTANT: If your clinic is NOT able to receive vaccine shipments during this period, update your availability in myCAvax by indicating a temporary closure in myCAvax to prevent shipping incidents leading to vaccine spoilage.
