2025-2026 VFC Influenza Vaccine Shipments Week of 9/29/2025

Dear VFC Provider,

The California Vaccines for Children (VFC) Program will continue processing influenza vaccine orders for providers who have pre-booked flu products. <u>Initial</u> orders for these providers will be processed at the end of this week for shipments arriving the week of September 29th, 2025. Percentages of initial orders that will ship are listed below.

<u>Product</u>	Age Group	Supply
Fluarix [®] 0.5mL, Single-Dose Syringe, GSK	6 months-18 years	Orders of 100 doses or less have already been shipped in full. Orders over 100 doses: An additional 10% will be shipped, totaling 50% of the total approved pre-book for the season.
Flucelvax® 0.5mL, Single-Dose Syringe, Seqirus	6 months-18 years	Orders of 100 doses or less have already been shipped in full. Orders over 100 doses: An additional 8% will be shipped, totaling 50% of the total approved pre-book for the season.
FluLaval [®] 0.5mL, Single-Dose Syringe, GSK	6 months-18 years	Orders of 100 doses or less have already been shipped in full. Orders over 100 doses: An additional 12% will be shipped, totaling 50% of the total approved pre-book for the season.
Fluzone® 0.5mL, Single-Dose Syringe, Sanofi	6 months-18 years	Orders of 100 doses or less have already been shipped in full. Orders over 100 doses: An additional 16% will be shipped, totaling 50% of

the total approved pre-book for the season. FluMist[®] Orders of 100 doses or less have 2-18 years 0.2mL, Nasal Sprayer, already been shipped in full. AstraZeneca Orders over 100 doses: An additional **38**% will be shipped, totaling 50% of the total approved pre-book for the season Fluad® 18 years with a Minimum order of 10 doses have 0.5mL, Single-Dose solid organ already been shipped. Syringe, Segirus transplant Fluzone High-Dose® 18 years with a Minimum order of 10 doses have 0.5 mL, Single-Dose solid organ already been shipped. Syringe, Sanofi transplant

Providers that pre-booked flu vaccine earlier this year do NOT need to submit a vaccine order form to receive their initial 2025-2026 flu vaccine shipments. If you did not pre-book flu vaccines, doses will be allocated based on remaining supply.

This round of shipments gives providers at least 50% of their total approved pre-book, and this now concludes the automatic shipments of flu orders. Any remaining pre-booked doses will be allocated to your account in early October. You can view your allocations by clicking on the "View Allocation Details" link on your myCAvax vaccine order form.

Once doses are allocated, you may request flu vaccine on your myCAvax routine VFC order form. Continue to request flu vaccine throughout the remainder of the flu season, up to your allocated amount.

IMPORTANT: If your clinic CANNOT receive shipments during this period, please notify the VFC Program immediately and update your availability in myCAvax by indicating a temporary closure to prevent shipping incidents leading to immunization spoilage.
