

2012-2013 CHILD CARE ASSESSMENT RESULTS

Introduction

The annual child care assessment is conducted each fall to monitor compliance with the California School Immunization Law. Results from this assessment are used to measure immunization coverage among children entering licensed child care facilities. This report presents results from this year’s child care assessment and the attached tables present comparisons of immunization coverage in child care facilities by county.

Methods and Participants

This year’s child care assessment was conducted in 9,525 of California’s licensed child care facilities. Child care facility staff completed assessment reports and submitted them to local health departments and the Immunization Branch. The age group assessed is 2 years to 4 years, 11 months. Roughly one-third of children in this age group attend licensed child care facilities. The following data are only for children in licensed child care facilities that have reported and may not be representative of the entire population of California children in this age group.

Results and Discussion

A summary of results from the Fall 2012-13 child care assessment are found below (Table 1). This year, 89.2% of the 484,413 children enrolled in reporting child care facilities received all required immunizations (4+ DTP, 3+ Polio, 1+ MMR, 1+ Hib, 3+ Hep B, and 1+ Vari or physician-documented varicella disease). There were 1,313 (0.27%) children with permanent medical exemptions (PMEs) and 14,081 (2.91%) children with personal belief exemptions (PBEs). For all facilities, immunization coverage was greater than or equal to 94% for each vaccine.

*Individual antigen status is unavailable for students with Personal Beliefs Exemptions. Therefore, individual antigen immunization coverage may be underestimated; anecdotal evidence suggests a small percentage of students may have some but not all required immunizations.

**Conditional Entrant is a student who does not meet all requirements. This student must be followed up because he/she: lacks (i.e., is not yet due for) at least one dose and does not have a personal beliefs or permanent medical exemption; or has a physician affidavit of Temporary Medical Exemption for one or more doses; or is a transfer student who has no record available yet.

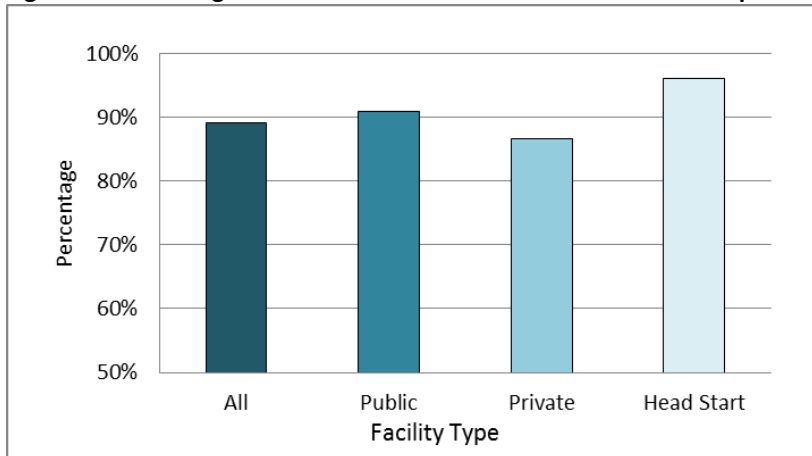


Figure 2: Percentage of California Child Care Enrollees Completing Required Vaccine Series by Facility Type

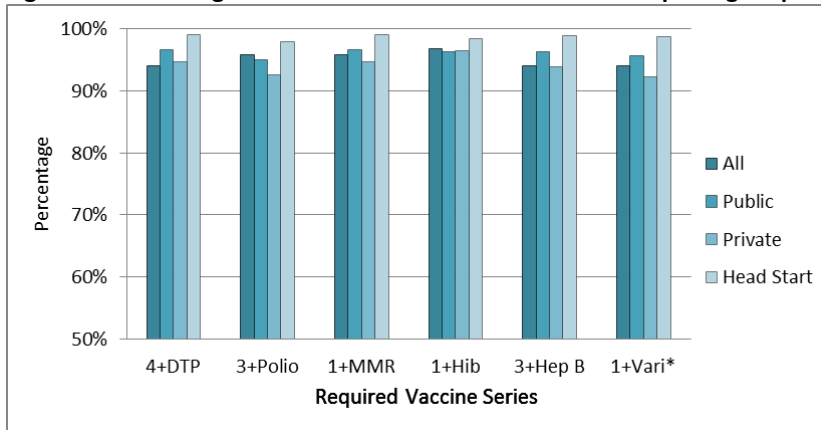


Figure 3: Percentage of Conditional Entrants Among California Child Care Enrollees by Facility Type

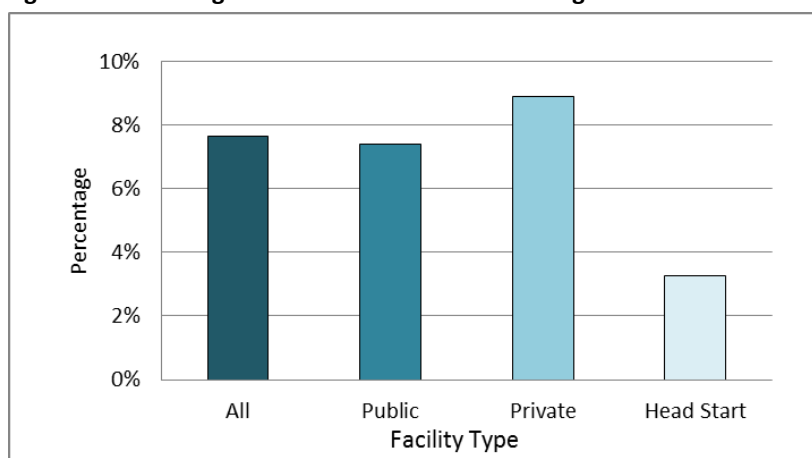


Figure 4: Percentage of Child Care Enrollees in California with Permanent Medical Exemptions by Facility Type

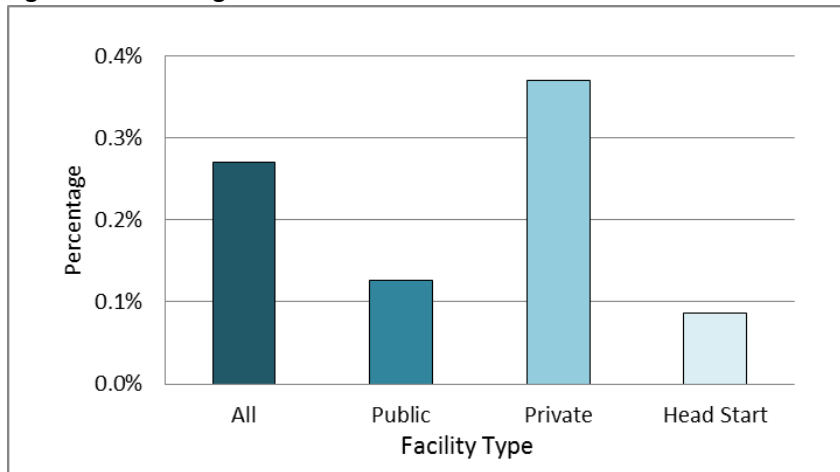
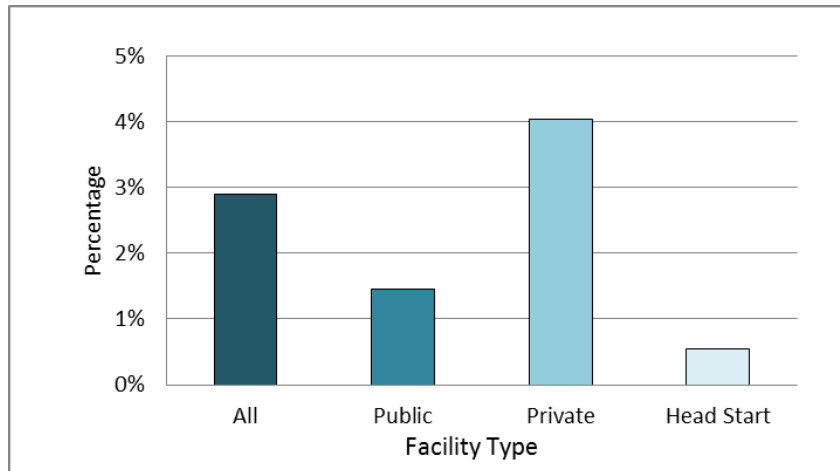


Figure 5: Percentage of Child Care Enrollees in California with a Personal Beliefs Exemption by Facility Type

The percentage of children receiving required vaccines and exemptions differed depending on facility type (Table 1). Head Start Facilities reported a higher percentage of children having received all required immunizations (Figure 1 and 2), and a lower percentage of conditional entrants (Figure 3) as well as children with exemptions (Figure 4 and 5) compared with public or private facilities. Private facilities reported a higher percentage of conditional entrants (Figure 3) and children with exemptions (Figure 4 and 5) compared with other facility types.

Figure 1: Percentage of California Child Care Enrollees with All Required Immunizations by Facility Type
