2016-2017 Child Care Immunization Assessment – Executive Summary California Department of Public Health, Immunization Branch

Immunization requirements for entry into child care facilities help protect children and communities from vaccine-preventable diseases. Each autumn licensed child care facilities in California are required under state immunization requirement laws to report to the California Department of Public Health (CDPH) the status of enrolled children. In recent years there have been changes to these laws and how public health departments assist facilities to implement them. In 2014 and 2015, Assembly Bill (AB) 2109 added stipulations for exemptions to required immunizations based on personal beliefs. For the 2016-2017 school year, Senate Bill (SB) 277 no longer permitted entrants to receive such personal beliefs exemptions (PBEs). During the 2015-2016 and 2016-2017 school years, many public health departments in California assisted facilities in correctly identifying and supporting eligible children, described as conditional entrants, who catch up with immunization requirements after entry.

Compared to the 2015-2016 school year, the proportion of children attending child care facilities in 2016-2017 reported to <u>have received all required vaccines</u> rose from 90.5% to 94.9%, a 4.4 percentage point increase over one year and a 5.5 percentage point increase over the two years since 2014-2015. The 2016-2017 rate of 94.9% is the highest reported for the current set of immunization requirements for child care facilities, which began in the 2001-2002 school year.

Completion rates for each <u>specific immunization series</u> also increased, in a range from 0.7 percentage points for *Haemophilus influenzae* type b (Hib) vaccine to 2.5 percentage points for Diphtheria, Tetanus, and Pertussis (DTP) vaccine. Four (7%) counties reported fewer than 95% of their children as having had one or more doses of MMR vaccine, compared to 17 (29%) counties in 2015-2016.

The proportion of children reported as <u>conditional entrants</u> declined from 6.7% in 2015-2016 to 1.8% in 2016-17, a 4.9 percentage point decrease over one year and a 5.6 percentage point decrease over the two years since 2014-2015. The present rate of 1.8% is the lowest yet reported for the current set of immunization requirements for child care attendance.

The proportion of children reported with <u>PBEs</u> decreased in 2016-2017 from 2.3% to 1.0% Under SB 277, PBEs remained valid for children who entered child care before 2016 and continued in child care during 2016-2017. Previously under measures specified in AB 2109, the rate of PBEs had decreased from 2.9% in 2013-2014 to 2.3% in 2015-2016.

The proportion of children reported with <u>permanent medical exemptions</u> decreased from 0.5% to 0.4% in 2016-2017. Another 0.1% of children were reported in a new category as lacking immunizations for <u>other reasons specified under SB 277</u>, specifically receipt of services in an individualized education program. The percentage of children reported as being <u>overdue</u> for required immunizations, another new category for 2016-2017 was 1.8%.

Possible explanations for the improvements in the reported immunization coverage of children in California include, but are not limited to:

- Efforts by public health departments, facilities, medical providers and partner organizations to help ensure that children meet immunization requirements.
- Increased public awareness about the importance of immunizations in the aftermath of outbreaks of vaccine-preventable diseases.
- The recent laws, SB 277 and AB 2109.

CDPH and local health departments in California continue to closely monitor immunization coverage and to support facilities in protecting the health of their children and communities.

2016-2017 Child Care Immunization Assessment – Technical Notes

Introduction

Each autumn licensed child care facilities in California are required to report compliance of children enrolled in their facilities with California School Immunization Laws (California Health and Safety Code Sections 120325-120375). This report summarizes data for the 2016-2017 school year reported by public, private and Head Start facilities statewide (Table 1, Figures 1-11) and by county (Tables 2-9, Figures 10 and 11).

In the 2014-2015 and 2015-2016 school years, entrants were subject to <u>Assembly Bill (AB)</u> <u>2109</u>, which added stipulations for exemptions to required immunizations based on personal beliefs. 2016-2017 is the first school year that entrants were subject to <u>Senate Bill (SB) 277</u>, which no longer permitted them to receive such personal beliefs exemptions (PBEs).

During the 2015-2016 and 2016-2017 school years, many public health departments in California worked with facilities to improve their application of the <u>Conditional Admission</u> <u>Immunization Schedule</u> for the conditional entrance of eligible children.

Methods

During the autumn of 2016, California child care facilities registered with the Department of Social Services, Community Care Licensing Division and the California Department of Education reported data on children 2 through 5 years of age enrolled in the 2016-2017 school year to the California Department of Public Health (CDPH). Based on their immunization status, school staff classified children into the following categories:

- Received <u>all required immunizations</u>, including the following doses:
 - o 4 or more of Diphtheria, Tetanus and Pertussis (DTP) vaccine
 - o 3 or more of Polio vaccine
 - o 1 or more of Measles, Mumps and Rubella (MMR) vaccine
 - 1 or more of *Haemophilus influenzae* type b (Hib)
 - o 3 or more of Hepatitis B (Hep B) vaccine, and
 - 1 or more of Varicella (Var) vaccine or a history documented by a physician of having had chickenpox.
- <u>Conditional entrants</u> who had:
 - o Not received all required doses but were not overdue for required doses, or
 - A temporary medical exemption to one or more required immunizations.
 - Conditional entrants are required to receive additional doses after entry.
- Have a permanent medical exemption (PME) to one or more required immunizations.
- Entered a child care facility prior to the 2016-2017 school year with a <u>personal beliefs</u> <u>exemption</u> (PBE) and continued in child care during the 2016-2017 school year. Under SB 277, PBEs were no longer an option for children entering child care in the 2016-2017 school year.
- Other children lacking immunizations, a new category. Under SB 277, children who have an individualized education program (IEP) may continue to receive all necessary services identified in their IEP regardless of their immunization status. Children were classified in this category if they lacked required immunizations and did not meet the criteria for other categories.

• Children <u>overdue</u> for one or more required immunizations and subject to exclusion from child care attendance until the overdue requirements have been met.

To simplify reporting, in prior years any immunizations received by children with PBEs or PMEs were not reported in the completion rates of each specific required immunization series (e.g., 4+ DTP, 1+ MMR, etc.). To improve accuracy, CDPH requested facilities to include these doses when reporting completion rates of specific immunizations in the 2016-2017 school year.

Due to rounding, total figures may differ from the sums of their components.

Results

The number of children enrolled in licensed child care facilities in California whose immunization status was reported increased by 3.0 percentage points from 484,984 in the 2015-2016 school year to 500,505 in 2016-2017 (Table 1). The number of facilities that reported increased by 0.7 percentage points from 9,335 to 9,398. The number of children and the number of facilities that were reported increased for each of the three major categories of child care facility - public, private, and Head Start. The largest increases were reported in private facilities, which accounted for 59% (296,589/500,505) of all children about whom data were reported in 2016-2017 and 56% (5,281/9,398) of all facilities that reported data on children.

Figures 1-5 show trends for children in public, private, and Head Start facilities reported as having: received all required immunizations; entered conditionally; PMEs; PBEs; and completed specific immunization series. Figures 6-9 display for recent school years the distribution of major reporting categories for children reported from: all facilities; public facilities; private facilities; and Head Start facilities.

<u>All required immunizations</u>: Of 500,505 children whose facilities reported their status, 475,191 (94.9%) had received all required immunizations, an increase from the previous school year of 4.4 percentage points (Table 1) and an increase over two school years of 5.5 percentage points (Figures 1, 6). Compared to the 2015-2016 school year, the percentage of children with all required immunizations increased in 56 (97%) of 58 counties (Table 5). For counties reporting at least 50 children, the highest rates were reported in Colusa, Trinity, and Modoc (≥98%) (Tables 3-5). In 2016-2017, 9 (16%) of 58 counties in California reported fewer than 90% of their children as having received all required vaccines, compared to 28 (48%) counties in 2015-2016 (Tables 4 and 5, Figure 10).

As in past years, the highest proportion of children reported as having had all required immunizations were in Head Start facilities (97.7%), compared to public (95.5%) and private (94.1%) facilities. However, the disparities between these categories have narrowed. In 2016-2017 the rates rose over one year by 5.6 percentage points (from 88.5% to 94.1%) in private facilities, 3.6 percentage points (from 91.9% to 95.5%) in public facilities, and 1.4 percentage points (from 96.3% to 97.7%) in Head Start facilities (Table 1, Figures 7-9).

<u>Specific immunizations</u>: Completion rates for specific immunizations increased between 0.7 percentage points for Hib to 2.5 percentage points for DTP (Tables 1 and 9, Figure 5). Rates of receipt were higher in Head Start facilities; for MMR, 99.5% of children at Head Start facilities, 98.7% at public facilities, and 97.7% at private facilities were reported as having received at least one dose, increases from 2015-2016 respectively of 0.6, 1.2 and 1.3 percentage points. In

2016-2017, 4 (7%) counties reported fewer than 95% of their children as having had one dose of MMR (Table 9, Figure 11), compared to 17 (29%) counties in 2015-2016.

<u>Conditional entrants</u>: Over the last two school years, the proportion of children reported as conditional entrants decreased from 6.7% in 2015-2016 to 1.8% in 2016-2017 (Table 1, Figures 2 and 6). Compared to the 2015-2016 school year, the proportion of conditional entrants in 2016-2017 decreased by 4.9 percentage points. The rate of conditional entrants decreased in each category of private (-5.6 percentage points), public (-4.9 percentage points), and Head Start (-1.6 percentage points) facilities (Table 1).

Of 58 counties, 56 (97%) reported overall reductions in conditional entrants, with the largest reductions in counties with more than 50 enrolled children reported for Placer (-15.5 percentage points) and Lake (-13.1% percentage points) Counties (Table 6). Of the 1.8% of children reported as conditional entrants in 2016-2017, 0.2% were reported as having had a temporary medical exemption.

<u>PMEs</u>: The percentage of children with PMEs decreased from 0.5% in 2015-2016 to 0.4% in 2016-2017 (Tables 1 and 7, Figure 3). In public facilities, the number of children reported with PMEs decreased from 396 (0.3%) to 209 (0.2%) (Figure 7). In private facilities, the number of children decreased from 1,848 (0.7%) to 1,505 (0.5%) (Figure 8). In Head Start facilities, the number of children reported with PMEs decreased from 87 (0.1%) to 42 (0.1%) (Figure 9).

<u>PBEs</u>: With the option of PBEs available to prior entrants but no longer to new entrants under SB 277, the percentage of children with PBEs in 2016-2017 was 1.0%, compared to 2.3% (-1.3 percentage points) in 2015-2016 and 2.9% (-1.9% percentage points) in 2013-2014 (Figures 4 and 6, Table 8). In 2016-2017 PBE rates declined over one year by 1.7 percentage points (from 3.2% to 1.5%) in private facilities, 0.9 percentage points (from 1.3% to 0.4%) in public facilities, and 0.3 percentage points (from 0.5% to 0.2%) in Head Start facilities (Table 1, Figures 7-9). The rates of PBEs continue to vary by county, with a range of 0% - 7.2% (Table 8).

<u>Other children lacking required immunizations</u>: In 2016-2017, 0.1% of children were reported to be lacking one or more required immunizations and to receive services specified in an IEP (Tables 1 and 3, Figure 6).

<u>Overdue</u>: In 2016-2017, 1.8% of children were reported as being overdue for one or more immunizations (Table 1, Figure 6). In public facilities the number of children reported as overdue was 2.2% compared with 1.9% in private facilities and 0.6% in Head Start facilities (Table 1, Figures 7-9).

<u>Combined categories</u>: Children who are required to receive all mandated vaccines are reported in three categories: having received all required vaccines; conditional entrants; and being overdue for required doses. The children who were reported in the sum of these three categories increased by 1.3 percentage points from 97.2% in 2015-2016 to 98.5% in 2016-2017.

Conversely the sum of children reported as not having to receive all required immunizations in child care facilities because of PMEs, PBEs, or, starting in the 2016-2017 school year, for other criteria specified in SB 277, decreased by 1.3% percentage points from 2.8% in 2015-2016 to 1.5% in 2016-2017; the combined rate decreased from 1.6% to 0.8% for public facilities, from 3.9% to 2.0% for private facilities, and from 0.6% to 0.3% in Head Start facilities.

Discussion

When comparing the 2016-2017 school year to 2015-2016, the proportion of children reported to enter child care in California after receiving all required immunizations increased by 4.4 percentage points to 94.9%, following an increase of 1.1 percentage points between the 2014-2015 and 2015-2016 school years. The 2016-2017 rate of 94.9% is the highest reported to CDPH since varicella vaccine became the most recent addition to the immunizations required for children, which began in the 2001-2002 school year.

The 5.5 percentage point increase in the receipt of all required vaccines over the previous two school years is similar in magnitude to a 5.6 percentage point decrease in children reported as conditional entrants. The proportion of conditional entrants decreased by 0.7 percentage points between 2014-2015 and 2015-2016 and 4.9 percentage points between the 2015-2016 and the 2016-2017 school years. The current reported rate of conditional entrants, 1.8%, is the lowest reported for the current panel of required immunizations in place since the 2001-2002 school year.

Since 2015 local health departments and CDPH have intensified efforts to educate child care staff on the proper use of conditional entrance criteria based on the <u>Conditional Admission</u> <u>Immunization Schedule</u>. It is likely that these measures to promote compliance have contributed to the decreases in children reported as conditional entrants and the increases in those reported as having received all required vaccines. These changes might also be attributable to an increased awareness of the risks of vaccine-preventable diseases and benefits of immunization, triggered in part by the measles outbreak that spread from Disneyland in December 2014 to at least 7 additional states and 2 other countries¹.

It is possible that children who in previous school years would have been inaccurately categorized as conditional entrants represent some of the 1.8% of entrants reported as overdue in 2016-2017. Many facilities that in the 2016-2017 school year have reported children as being overdue for required immunizations instead reported in prior school years higher rates of conditional entrants; they have also reported low rates for the other categories of children without all required immunizations. Continued efforts to educate facilities and support immunization services might further reduce the number of children who are categorized at the beginning of the future school years either as conditional entrants or overdue; in sum these categories account for 3.6% of children reported in 2016-2017.

With the additional measures required under AB 2109 for requesting PBEs during 2014 and 2015, the rate of PBEs decreased from 2.9% in 2013-2014 to 2.3% in 2015-2016. With the implementation of SB 277 and the cessation of PBEs for new (but not prior) entrants, the percentage of children with PBEs in 2016-2017 has decreased to 1.0%. As children currently in child care advance to kindergarten, the proportion of children with PBEs is expected to decrease to zero. In 2016-2017, 0.4% of children were reported with PMEs, and another 0.1% lacked required immunizations under other criteria introduced in SB 277. Entrants reported as not having had required immunizations because of PBEs, PMEs or other criteria related to SB 277, decreased from 2.8% in 2015-2016 to 1.5% in 2016-2017. Future assessments will follow the trends for these measurements as children no longer qualify for PBEs.

Despite the improvements in reported immunization rates, children in facilities and communities with lower rates remain at higher risk of contracting and transmitting vaccine preventable diseases. In 2016-2017, 9 (16%) of 58 counties in California reported rates of children with all required vaccines that are below 90% (Figure 10), compared to 28 (48%) in 2015-2016. The number of counties that report fewer than 95% of their children as having had one dose of MMR (Table 9, Figure 11), decreased from 17 (29%) in 2015-2016 to 4 (7%) in 2016-2017. As an additional source of vulnerability, recent changes to California's school immunization laws did not apply to earlier cohorts of children who are no longer of school age. Unimmunized older children and adults were amongst those who caught measles in the Disneyland outbreak in 2014 and 2015. For these individuals, decisions that were made in previous decades to decline immunization have had lingering consequences for themselves and their communities.

Limitations

This report is subject to limitations that include:

- 1,299 California child care facilities, including 629 private facilities, 159 public facilities, 42 Head Start facilities and 469 facilities of unknown type did not report their immunization data; in the absence of reporting, CDPH does not know how many of them enrolled children this year or the immunization status of any enrollees.
- Part of the relative improvements in the completion rates of specific vaccines may have been due to the inclusion in reporting this year of doses received by partially immunized children who had PBEs or PMEs to other required immunizations. In reporting to CDPH during prior school years, doses received by children with exemptions were not included in completion rates for any specific vaccine. This may have resulted in underestimates of completion rates in prior years and overestimates of the increases in the completion rates for specific vaccines between 2016-2017 and prior years. The magnitude of the resultant increase to the rate of any immunization series in 2016-2017 resulting from this change in reporting could be no greater than 1.5%, the total of children reported in categories as not having to receive all required immunizations (PMEs, PBEs or the new category of other criteria specified in SB 277). This reporting change should not have affected rates, or changes in rates, for the category of having received all required vaccines.
- The timing of immunization is often not included in the assessment criteria; if doses were given at inappropriate ages or intervals, the reported rates may overestimate levels of immunity.
- It is possible that some immunization records provided to facilities have been incomplete. The presence of incomplete records would underestimate immunization coverage. Any improvements over time in completion of records since the time of reporting would increase estimates of coverage.
- Changes over time in the quality of reporting by facilities are another potential explanation for changes in immunization rates.




Figure 1. Percentage of Children with All Required Immunizations, by Facility Type and School Year, 2011-2012 to 2016-2017




Figure 2. Percentage of Conditional Entrants into Child Care, by Facility Type and School Year, 2011-2012 to 2016-2017




Figure 3. Percentage of Children with Permanent Medical Exemptions (PMEs), by Facility Type and School Year, 2011-2012 to 2016-2017




Figure 4. Percentage of Children with Personal Belief Exemptions (PBEs), by Facility Type and School Year, 2011-2012 to 2016-2017






Figure 5. Percentage of Children with Specific Required Immunizations by Series and School Year, 2011-2012 to 2016-2017







Figure 7. Percentage of Children in Public Facilities by Reported Admission Status by School Year, 2015-2016 and 2016-2017






Figure 9. Percentage of Children in Head Start Facilities by Reported Admission Status by School Year, 2015-2016 and 2016-2017
