VFC Program Update

Dear VFC Provider,

Please refer to the following updates regarding VFC's Program's operations, vaccine orders and shipments:

VFC Program Operations during the Federal Government's Partial Shutdown

- The Vaccines for Children (VFC) Program is a federal entitlement program supported through mandatory funding, and continues to operate during the government's partial shutdown.
- Program operations at the state level also continue according to business hours; provider orders and calls continue to be received at the program's Customer Service Center.

Vaccine Shipment Packing Slip Changes

- Effective October 3, 2013, all vaccine shipments' packing slips will be slightly modified to comply with a federal requirement to identify funding sources used to purchase publicly funded vaccines. A sample of the new packing slip is included in this communication.
- The majority of VFC providers will see doses ordered for each vaccine in the "VFC Doses" column.
- Local Health Departments (and their approved sites) eligible to receive 317 and state general fund vaccines will also see doses ordered in the "317 Doses" and "State Doses" columns.

Order Processing & Vaccine Shipments

- Due to required federal changes in the program's vaccine order processing system, all approved vaccine orders received during the earlier part of this week were held in queue until changed were implemented.
- Orders were successfully transmitted to McKesson Specialty on 10/2/2013 and orders began to ship today according to
 provider's reported business hours.
